## The following are typical situations of what Passaic County Consumer Parents are facing:

- After years of struggling with her mental illness and her role as a parent, "Nilda" found the courage she needed to reach out for assistance. She has been raising four children on her own and has not received treatment or medication because she could not afford it.
- "Liz" is a parent coping with depression. Sometimes her symptoms were so severe she could not find the energy to care for her children or maintain her household. She did not seek assistance for herself because she was afraid of the stigma associated with mental illness.
- "Theresa" is a single mother with a 13 year old son. In addition to losing her therapist and psychiatrist because her insurance would no longer cover these costs, her son was diagnosed with Attention Deficit Hyperactivity Disorder.

## **Some Facts About Mental Health**

- 1 in 5 Americans will be affected by a mental illness at some time in their life.
- According to the US Surgeon General's
   Report on Mental Health, mood disorders, including Depression and Bipolar Disorder, are significant causes of disability the world over.
- Almost one-fourth of women and 15% of men in this country will cope with Depression and other associated disorders during their lifetime. The majority of these men and women are parents.

# The Consumer Parent Support Network recognizes the importance of the relationship between parents and their children. Our staff has first-hand experience and know that parents need someone who believes in them and will provide support to them in their role as parents.
