MAHWAH POLICE AND MUNICIPAL ALLIANCE

Alliance Program which is the largest network of community-based antidrug coalitions in the USA. Volunteers serve on Alliances in more than 530 municipalities throughout NJ. Municipal Alliances are established by ordinance and engage residents, local government and law enforcement, schools, parents, youth and other allies in efforts to prevent alcoholism and drug abuse in NJ.

The program is funded from the Drug Education Demand Reduction Fund established to collect fines from individuals convicted of a drug offense. MA award recipients match Council grants with a cash-match of 25% and in-kind-services. This match requirement doubles the impact of these grants to total nearly \$20 million per year in programs and activities.

In Mahwah (one of NJ's newest Stigma Free Zones) the Mahwah MA is hard at work raising awareness of addiction in the NJ suburbs, educating the public and eradicating stigma. The Mahwah MA is a non-profit with an appointed director, Ms. Dana Romano. She acts as advocate and liaison for residents and families struggling with addiction. The MMA operates with a board and president, working in cooperation with police, schools and other officials to fight the heroin and opioid epidemic waging locally, particularly against the young.

Watch the two videos, below, to learn more about the public health crisis of prescription drug and heroin abuse in our area, and the Heroin Addiction Recovery Team (HART) Program currently being piloted in Mahwah and in several other surrounding police stations.

Local people with addictions are now encouraged to turn over drugs in their possession and enter a recovery program vs. facing charges or fearing prosecution for possession. Currently,

A FRANK AND OPEN LETTER ABOUT HEROIN TO ALL BERGEN COUNTY RESIDENTS

from the Bergen County Prosecutor's Office



Over the next few days, our office would like to extend some very stark and true thoughts on Bergen County's heroin drug epidemic that is wreaking havoc amongst our young men and women, often resulting in death by overdose.

In each notice, we will share with you our thoughts and intentions over the enforcement of our New Jersey Law entitled STRICT LIABILITY FOR DRUG INDUCED DEATHS.

Most believe that our drug laws are applied to "street dealers". To many, these "dealers" are the ones responsible for our drug epidemic. Think again. We are all responsible. Consider this scenario:

You run a good household in suburban Bergen County. You have a house, a great job and great kids who all went to college and are just starting out on the life that you have given them.

Your 23 year old son still lives at home, has a great job and a girlfriend. He is a good kid.

You have some Oxycodone pills in your medicine cabinet. You were prescribed them a year ago. You do not take them but they remain in your bathroom cabinet. You don't know why. All of us have done this at some point in time.

Your son would never take the "oxy". He is a good kid.

But your son's girlfriend has a friend.

You don't know this friend.

This friend has a drug problem and asks your son to get him an "oxy" pill.

Your son knows that he should not do it, but gives his girlfriend the "oxy" pill anyway to give to the friend.

The friend takes the pill. Unbeknownst to you, your son and his girlfriend, it's his tenth of the day, in addition to many other pills that other friends have given him.

The friend dies from all of this. Not just the pill that your son's girlfriend gave him, but based on everything that he took that day.

BOROUGH OF FRANKLIN LAKES "AMNESTY" POLICY

The fear of criminal prosecution can cause persons who suffer from opioid drug addiction (addiction to heroin or to opiate-based drugs like Percocet or Vicodin) to elect not to seek needed assistance with their addictions. Recognizing that getting help for those in the downward spiral of drug addiction is far more important than penalizing them, the Borough of Franklin Lakes Police Department, consistent with a directive from the Bergen County Prosecutor's Office, has implemented the following policy:

Individuals who advise the Franklin Lakes Police Department that they are addicted to opioids and need help will not be charged with a crime or prosecuted, but will, instead, be referred to appropriate drug counseling and addiction recovery services. If such opioid-dependent individuals are referred to us by parents, children, spouses, guardians or siblings, they will be treated in the same manner as if those individuals had themselves provided the advice to us.

In other words, the Franklin Lakes Police Department will provide whatever help it can to addicts who themselves seek help or for whom help is sought by other persons (such as parents, siblings, spouses, children, etc.). Under those circumstances the addicts will not be arrested and brought through the criminal justice system, but would, instead, be referred for appropriate drug counseling and addiction recovery services.

Since the introduction fourteen months ago to our patrol officers of Narcan, a prescription medicine that blocks the effects of opioids and can reverse an overdose, our officers have saved the lives of six overdose victims. Absent the drug, that would have been six fatalities in just over one year's time within the borders of Franklin Lakes. The problem is here and the Police Department is committed to addressing it head on. Let's work together, outside the criminal justice framework, to save lives.

At its meeting held on March 15, 2016, the Mayor and Council of the Borough of Franklin Lakes, by resolution, endorsed the implementation of the above Amnesty Policy

After 3 long years of work by its Pastoral Care Committee, Central Unitarian Church has proudly hung a banner with a message of support for people with mental health challenges in front of their sanctuary on Forest Avenue; one of the busiest streets in Paramus.

The church's Pastoral Care Committee, under the leadership of Reverend David Horst, have dedicated a yearly sermon to the stigma surrounding mental illness and created support groups for church families with children with mental health and addiction challenges. They have also hosted interfaith events educating other faith communities on fighting stigma, they support their local NAMI and many church members have fundraised for mental health organizations and causes.

Growing this advocacy was not without controversy within the church. At first, members expressed fears that outreach into the mental health community might result in "problems for the congregation". Asking the faith community to join the Stigma Free Zone coalition was a long process, requiring education of the church's board of trustees to still fears coming from stigma and convincing the congregation that fighting for the safety, health and rights of people with mental illness was indeed,

Well done!

Education has lessened the general fear of people with mental health challenges among CUC congregants, they have not experienced any adverse events since publicly taking on the fight against mental health stigma, and they discovered some among their own who, given the chance, were happy and eager to talk about their challenges or those of a family member living with an illness.

The Church unanimously voted 200-0 to join the Paramus Stigma Free Zone in 2015 and their Pastoral Care Committee was one of 10 religious organizations in NJ to receive the NJ Governor's Award for Fighting Stigma in April, 2016.


